- 6.Pre-bid meeting will be held in Gaidahwa Rural Municipality, Rupandehi Nepal, at 11.00 hrs on22th Bhadra 2080 (8th september 2023).
- 7. Electronic bids must be submitted to the Gaidahwa Rural Municipality, Rupandehi by electronically through PPMO website www.bolpatra.gov.np/egpon or before 12:00 hrs on 31st Bhadra 2080 (17th sept. 2023). Bids received after this deadline will be rejected.
- **8.** All bids shall be accompanied by a Bid Security for the amount as specified in the table. Bidders are required to submit a separate bid security for each contract for which they submit bids. The bid security guarantee issued only by the commercial bank approved by Nepal Rastra Bank shall be accepted by the Employer. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, which shall be valid for 30 days beyond the validity period of the bid.

- 10. If the last date of pre-bid meeting, purchasing and /or submission falls on a government holiday, then the same time on next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
